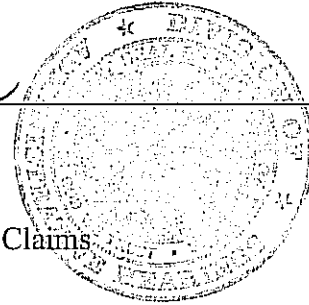
WHEREFORE IT IS ORDERED:
